GREETINGS TO ALUMNI

Charles F. Deiss

It is always pleasant to send greetings to such successful and enthusiastic colleagues as the geo-alumni of Indiana University. Not only are the men who graduated a quarter of a century ago occupying responsible positions in the major companies, but I. U. graduates in geology during the past six years are making themselves useful and important to the oil and mining industries. We are receiving complimentary reports about many of these graduates from their supervisors and from officials in the companies.

Each member of the geology faculty is aware of his responsibility to his students, and of the importance of the quality and kind of training they must have if they are to be useful to their employers and to society, as well as to the geologic profession.

You will be interested to learn that we shall have our largest number of Fellows and Teaching Assistants from other colleges and universities next year for graduate training. The enrollment, however, of our own geology majors is down, as it is in geology departments throughout the country. The military draft for the Korean War, the many jobs with large beginning salaries for A.B. and B.S. graduates, and the fact that engineers, chemists, and physicists are doing a better job of advertising their professions throughout the country than are geologists - all are responsible for the decline in geology students.

In order to stimulate scholarship and increase the enthusiasm and competition among the undergraduates in the department, the Geology Faculty personally bought a Brunton compass which was awarded in September 1952 to the senior with the highest academic record during his previous two years. I think you will agree that it is healthy and admirable when faculty members volunteer to contribute from their never-too-great salary to the ideal of higher scholarly standards and attainment.

The more significant changes in the curriculum during the past year have been the addition of a course in sedimentation taught by Professor Haydn Murray, our Clay Mineralogist; the decision to teach sedimentary petrology from the point of view of clay mineralogy beginning next year; and the enlargement and consolidation of the instrument and carpenter shops in order to provide better facilities for making new special equipment for the research of the entire faculty and graduate students.

Ralph Esarey and I were genuinely sorry that we were unable to attend the honorary luncheon which the alumni gave on March 25 for Professor Galloway in Houston, Texas, at the A.A.P.G. meetings. The luncheon was given in honor of Dr. Galloway's high achievement in micropaleontology and the distinction which he has brought to the geology department at I.U. His retirement in June this year will take from us the greatest living micropaleontologist.

The Editor, Professor W. D. (Bill) Thornbury, did not receive a single letter or post card from any of you concerning the first NEWSLETTER which was distributed in June 1952. Some of you commented about it in person and by letter to Ralph Esarey and other faculty members. The Editor

would like to know if you think the NEWSLETTER is worthwhile. If you do, he particularly would like to have your suggestions concerning its contents and methods of improving it. Your comments and suggestions have been helpful and the Editor would appreciate your taking the time to write him your reaction to this edition of the NEWSLETTER.

FACULTY ACTIVITIES DURING SUMMER OF 1952

Prof. J. J. Galloway and Harold Kaska completed a monograph on "The Genus *Pentremites* and its species" which is to be published as a Memoir by the Geological Society of America. Mr. Kaska used part of the monograph as his Master's thesis.

Professor Charles J. Vitaliano spent the summer at Socorro, New Mexico. There, in collaboration with Dr. Callaghan, he began assembling the major report on the studies made at Gabbs, Nevada. At the end of the summer the Vitaliano family took a ten-day vacation trip into Mexico.

Professor Brian H. Mason represented Indiana University at the nineteenth session of the International Geological Congress, held at Algiers, September 8-15. Before the session he took part in a fourteen day excursion to study the geology of the coastal regions of Tunisia and Algeria and after the session spent three weeks in Morocco visiting mineral deposits. He obtained some excellent material for the department's mineral collections.

Professor Thomas G. Perry spent the summer completing the work begun the previous summer in establishing the areal distribution of the Chester (Upper Mississippian) rocks in Indiana. The results of this work are to be published as a bulletin of the State Geological Survey.

Professor Haydn H. Murray continued his work for the State Geological Survey collecting samples of clays and shales for the purpose of determining their possible economic value as raw materials in the ceramics industry. He also attended and participated in the first National Clay Conference, held at the University of California at Berkeley.

Professors Esarey and Thornbury spent a part of the summer at the Geologic Field Station in Montana. They managed to stay within shouting distance of most of their students and particularly enjoyed the social activities at Whitehall.

Professor R. E. Deane spent the summer as chief contractor, carpenter, electrician, plumber, stone-mason, etc. on the new home which the Deanes are building. If the time should ever come when he finds it impossible to live on a professor's salary, he should be able to qualify as a master craftsman in any one of several crafts.

Professor Wayne R. Lowell was in charge of summer camp in Montana during the field season and spent the remainder of the summer, along with a half dozen of the more sturdy students, searching for phosphate deposits for the Victor Chemical Company.

Professor Judson Mead spent the summer in Bloomington doing geophysical research.

Professor J. B. Patton spent the summer supervising various phases of the State Geological Survey's program on industrial minerals.

Dr. Deiss spent his summer examining granite, marble, and slate quarries as Chairman of the Dimension Stone Committee of the American Institute of Mining Engineers. He also spent three weeks at the Geologic Field Station in Montana and the remainder of the summer checking field parties for the Geological Survey in Indiana.

GEOLOGICAL SURVEY ACTIVITIES

Changes in Personnel.

Harold Hutchison returned to his duties as Geologist in the Coal Section in April 1953, after 21 months of active duty with the Navy.

James T. Stanley, who was a geologist in the Coal Section until May 1952, left for employment as a petroleum geologist at Vernal, Utah, and is now located at Rawlins, Wyoming.

S. Arthur Friedman joined the Coal Section as a Geologist June 15, 1952 after completing an A. M. degree at the Ohio State University.

Charles E. Wier, Head of the Coal Section, is on leave from the Survey during the current semester to complete the course work for his doctoral degree.

Robert F. Blakely has been transferred to the position of Physicist in the Geophysics Section and his place in the Spectrographic Laboratory has been filled by T. C. Yao, who joined the Survey after employment as a chemist with Commercial Solvents Corporation at Terre Haute, Indiana.

In the Industrial Minerals Section, the position of Petrographer was set up in September 1952, and Seymour Greenberg, who had recently completed his work for the master's degree, was appointed to fill the position. He is now on leave for military service, having left in March of this year.

Investigations.

The Geophysics Section has carried out extensive investigations to determine the depth and character of glacial drift and the underlying bedrock in several areas where the status of groundwater supply and the installation of artificial reservoirs required such information.

In the Industrial Minerals Section an extensive investigation for high-silica sands was carried out during the summer of 1952. Report of Progress No. 5, "Preliminary Report on High-Silica Sand in Indiana," has recently been issued, and laboratory work is continuing on the petrographic character of the sands and possible methods of beneficiation. A new investigation of clays and shales suitable for the production of light-weight aggregate has just been started.

The Glacial Geology Section has made a study of the distribution and possible origin of the Ohio River formation to supplement the work on the high-silica potentialities of the formation.

The Petroleum Section has completed well location and total depth maps of a number of additional counties around the outer rim of the Illinois Basin.

During the year, a new series of publications entitled the Circular Series was inaugurated. In addition, the "Atlas of Mineral Resources of Indiana" was begun with the issue of maps showing the locations of active sand and gravel pits and active clay and shale pits and mines.
